PENELOPE REED KC

RAJ ARUMUGAM

Raj has been involved in major offshore disputes such as the *Investec Trust v. Glenalla* litigation, *Carlyle Capital Corporation v. Michie [2020] EWHC 54 (Ch).*

Before joining the Bar, Raj was a solicitor in the City, qualifying at Herbert Smith in 2002 and then practising for 6 years as a commercial litigator at a leading US law firm. Raj has also spent 6 months seconded to a leading offshore law firm. As a result, Raj is a team player who understands the needs of solicitors and overseas lawyers when instructing counsel. Raj has been appointed to the Attorney General's B Panel of Junior Counsel. He regularly represents and advises Government departments and public bodies including HMRC, HM Treasury, BEIS, and the Official Receiver. In 2008, Raj served as a Judicial Assistant in the Court of Appeal (working principally for the then Lady Justice Arden). This gave Raj an invaluable insight into appellate work.



MATHEW ROPER

Mathew has a broad contentious and non-contentious Chancery practice, with an emphasis on trusts and estates, capital taxation, the property and affairs jurisdiction of the Court of Protection and related professional negligence.

Mathew's contentious cases include *Cotton v Earl of Cardigan* (blessing of a momentous decision); *Barton v Willey* (undue influence and unconscionable bargain (led by David Rees KC)) *Fielden v Christie-Miller* (rectification of a deed of appointment and proprietary estoppel (led by Penelope Reed KC)); *RNLI v Headley* (extent of a trustee's duty to account); *Bullard v Bullard* (rectification of a settlement); *ADS v DSM* (application for a statutory will (led by Christopher Tidmarsh KC)); *Re AR* (authority and remuneration of deputies); *Re KP* (expenses of deputies); *Brown v New Quadrant Trust Corporation* (injunction to restrain sale of shares in breach of trust and cross-application for a blessing); and *Almond v Goff* (will construction (led by Tracy Angus KC)).



OLIVER MARRE

Oliver has a practice encompassing all areas of tax law, both contentious and non-contentious. This year's Legal 500 directory listed him as a leading practitioner with the comment: "The best service and most thorough, practical advice for us and our clients."
